# C. MONOLOGUE SCRIPT

I was born in Mingora in Pakistan on July 12, 1997. My father, Ziauddin, was a teacher. He ran a girls' school in our village. I always loved school. One day, extremists took control of our town in Swat Valley. Everything changed. The extremists banned many things. They prohibited us from watching television and playing music. If we didn't follow their rules, they would punish us cruelly. They also said that girls must not go to school.

After the ban, only 11 out of 27 students attended classes. I wanted to change this. So, I spoke out in public to support girls' rights to learn. This made me a target. In October, 2012, on my way home from school, a masked gunman boarded my school bus. He shouted, "Who is Malala?" I was so afraid that I didn't say anything. Suddenly, he shot me on the left side of my head.

I woke up 10 days later in a hospital in Birmingham in England. The doctors and nurses told me

about the attack. They said people all around the world were praying for my recovery. After months of surgeries and rehabilitation, I joined my family in our new home in the U.K. I could live a quiet life but I decided to make the most of this new life. I was determined to continue my fight until every girl could go to school. My name is Malala Yosafzai.
